SECTION 7. Handling and storage

7.1. Precautions for safe handling

Due to the organic solvents' content of the preparation:

Vapours are heavier than air and may spread along floors. Vapours may form explosive mixtures with air. Prevent the creation of flammable or explosive concentrations of vapour in air and avoid vapour concentration higher than the occupational exposure limits. In addition, the product should only be used in areas from which all naked lights and other sources of ignition have been excluded. Electrical equipment should be protected to the appropriate standard. Preparation may charge electrostatically: always use earthing leads when transferring from one container to another. Operators should wear anti-static footwear and clothing and floors should be of the conducting type. Keep container tightly closed. Isolate from sources of heat, sparks and open flame. No sparking tools should be used. Avoid skin and eye contact. Avoid the inhalation of dust, particulates and spray mist arising from the application of this preparation. Avoid inhalation of dust from sanding. Smoking, eating and drinking should be prohibited in application area. For personal protection see Section 8. Never use pressure to empty : container is not a pressure vessel. Always keep in containers of same material as the original one. Comply with the health and safety at work laws.

When operators, whether spraying or not, have to work inside the spray booth, ventilation is unlikely to be sufficient to control particulates and solvent vapour in all cases. In such circumstances they should wear a compressed air-fed respirator during the spraying process and until such time as the particulates and solvent vapour concentration has fallen below the exposure limits.

Materials such as cleaning rags, paper wipes and protective clothing, which are contaminated with the product may spontaneously self-ignite some hours later. To avoid the risks of fires, all contaminated materials should be:

- stored in purpose-built containers or in metal containers with tight-fitting self-closing lids.

or

- laid out flat in a single layer to dry.

or

- placed in a closed metal container soaked with water.

or

- washed out well with warm soapy water before disposal.

Contaminated materials should be removed from the workplace at the end of each working day and be stored outside.
