7.1. Precautions for safe handling

Additional hazards when processed

: Due to the organic solvents' content of the preparation: Vapours are heavier than air and may spread along floors. Vapours may form explosive mixtures with air. Prevent the creation of flammable or explosive concentrations of vapour in air and avoid vapour concentration higher than the occupational exposure limits.

Precautions for safe handling

Prevent the creation of flammable or explosive concentrations of vapour in air and avoid vapour concentrations higher than the occupational exposure limits. In addition, the product should only be used in areas from which all naked lights and other sources of ignition have been excluded. Electrical equipment should be protected to the appropriate standard. Preparation may charge electrostatically: always use earthing leads when transferring from one container to another. Operators should wear anti-static footwear and clothing and floors should be of the conducting type. Keep container tightly closed. Avoid skin and eye contact. Avoid the inhalation of dust, particulates and spray mist arising from the application of this preparation. Avoid inhalation of dust from sanding. For personal protection see Section 8. 8.2. Exposure controls

Appropriate engineering controls:
